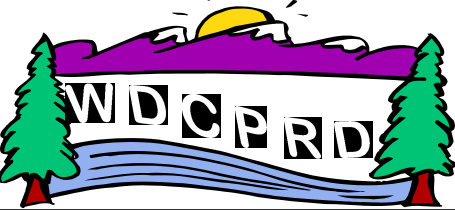

For each additional hour above the 2 hour minimum the charge will be 1/2 that of the 2 hour rate. Example: 76-100 people @3 hours = \$200.00 + \$100.00 = \$300

No vehicles beyond designated parking area – equipment unloading and loading only – all vehicles must exit before event.

No glass containers.

No alcoholic beverages allowed

NO SMOKING permitted within 200 feet of pool facility

Immediately following my event I will clean the area(s) used, garbage cans emptied (replaced with 33 gallon trash can liners) and trash hauled away

I understand that my party/organization and its officers accept full responsibility for the use of Lowden Park Pool and that I am liable for any damages or injuries that may occur.

A holding deposit of ½ rate is required at time of reservation to hold facility date – **This amount will be deposited by WDCPRD.** \$25.00 will be a non refundable deposit to be used for a holding/cancellation fee explained below. Full amount must be paid no later than 7 days before rental date.

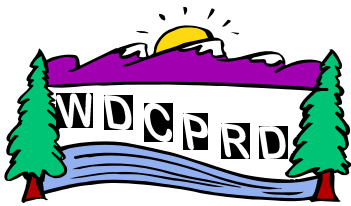
If my reservation is cancelled with 1 week (7 days) or less notice before event the above fee is charged.

If my reservation is cancelled less than 2 weeks (14 days) notice, I will receive refund of monies paid minus \$25.00 toward a rental loss fee as bookings for rentals are extremely demanding and it may cause a loss of revenue for the pool.
