## **ORDINANCE NO. 15-01**

# LEE FONG PARK RULES & REGULATIONS

THE BOARD OF DIRECTORS OF THE WEAVERVILLE/DOUGLAS CITY PARKS AND RECREATION DISTRICT DOES ORDAIN AS FOLLOWS:

#### 1. TITLE:

This chapter shall be known as the "Lee Fong Park Ordinance". It is the purpose of this Chapter to establish rules and regulations for Lee Fong Park and in accordance with the following Trinity County Ordinance Chapters:

8.32.000 - 8.32.030 SMOKING IN FIRE HAZARD AREAS

8.40.000 - 8.40.080 FISHING ACCESS AND DAY USE AREAS

8.52.000 - 8/52.070 BREAKABLE GLASS CONTAINERS - TO EXTEND THE COUNTY'S "PARK ORDINANCE" TO INCLUDE LEE FONG PARK

CVC 38026 - OFF HIGHWAY VEHICLES PROHIBITED ON PARK PROPERTY

#### **DEFINITIONS**

- A. 'Board' means the Board of Directors of Weaverville/Douglas City Parks and Recreation District.
- B. 'Day' means those hours beginning at six o'clock a.m. and ending at eleven o'clock p.m.
- C. 'Night' means those hours beginning at eleven o'clock p.m. and ending at six o'clock a.m.
- D. 'Park' means the Lee Fong Park.
- E. 'General Manager' means the General Manager of the Weaverville/Douglas City Parks and Recreation District.
- F. 'Person' means natural person, corporation, company, partnership, trust, firm, non-profit or association of persons.
- G. 'Vehicle' means any motorized vehicle as defined in California Vehicle Code Section 670.

### 2. GENERAL INFORMATION

Months of Operation. Lee Fong Park is generally open to the public and available for private rentals from April 1<sup>st</sup> – October 31<sup>st</sup>. The park may open and or close a month earlier and or later in the event of warmer and or colder than usual weather.

<u>Hours.</u> The hours of Lee Fong Park are hereby established from six o'clock a.m. to eleven o'clock p.m. No person shall arrive before or remain after the established hours without approval from the General Manager or Board by bearing proof of an approved 'Application For Use Of Facilities' and / or an approved camping permit issued by the District.

No changes or additions to the facilities, equipment or structures are allowed without the approval of the General Manager or Board.

<u>Restrictions.</u> The General Manager or Board may place restrictions and/or conditions, including, but not limited to: hours of use, clean-up, method of supervision required for an event, insurance, charges for the use of park grounds and facilities. Conditions must first be met by the renter before the event and the restrictions must be complied with during the use of the park.

<u>Vehicles.</u> No person shall place, drive or operate any type of motor vehicle in any area of the park (except parking lot) without the prior written approval of the General Manager or Board. Speed of vehicles entering into the designated parking lot shall not exceed 15 miles per hour.

### 3. PROHIBITED ACTS

### A. Day/Night Use

- No Person Shall use Lee Fong Park land for camping; Persons may not camp within park boundaries including parking lot. All personal property must be removed and park vacated by eleven o'clock p.m.;
- 2. No Person Shall arrive before or remain after the established hours;
- 3. No Person Shall mutilate, deface, remove, disturb, injure or destroy any natural, man-made feature and or property of said park;
- No Person Shall post, place or erect any paper, notice, advertising material, sigh or similar Matter without specific written approval for same from the General Manager or Board;
- 5. No Person Shall use any type of breakable glass drinking container, including water, beer, wine and pop bottles. They shall be prohibited from said park.

### B. Sanitation

- 1. No Person Shall deposit refuse, trash, rubbish or waste in any waters contiguous to or anywhere on the grounds or in the facilities of said park. Persons shall place such refuse or trash in proper receptacles where they are provided. Where such receptacles are not provided, all such materials shall be carried away from the area by the person responsible for its presence, locate proper receptacles and properly dispose of it, or take it with you.
- 2. No Person Shall bring or deposit any refuse or trash, not generated by general use or activities related to general use of said park for disposal thereon.

### C. Operation of Vehicles

- 1. No Person Shall place a vehicle or any other object in such a manner that it is an impediment or hazard to the safety or convenience of any person.
- 2. No Person Shall block, restrict or otherwise interfere with the use of any road, trail or park access.
- No Person Shall place, drive, or operate any type of motor vehicle such as but not limited to automobiles, trucks, recreational vehicles, motorcycles, quads, or motor scooters within the boundaries of the park without specific approval for same from the General Manager or Board.
- 4. No Person Shall abandon a vehicle, animal or any such item of personal property at said park. Unattended personal belongings will be removed by park personnel at the time of closing or upon opening.

### D. Sound Amplification

1. The General Manager or Board may establish reasonable restrictions on the requested use of sound amplification. Any violation of any one or more of such conditions shall be cause for immediate revocation of the Application For Use Of Facilities. Determination of violation may be made by the General Manager, Board, their deputized agent, or any law enforcement official, and the decision shall not be subject to administrative appeal.

#### E. Smoking

- Smoking tobacco products is limited to the Lee Fong Park paved parking lot only.
- Smoking (to include Electronic Smoking Devices) any substance is not allowed in or upon Lee Fong Park grounds or facilities.
- It shall be unlawful to dispose of any smoking material upon the grounds, in facilities or upon the paved parking lot.
- 4. It shall be unlawful if any person fails to extinguish any smoking material when requested to do so by any other person, park official, county official or any law enforcement official. A violation of this subsection shall be punishable under 'Violation' - Penalty listed below.

#### F Fires

- 1. No Person Shall have an 'open' fire anywhere in said park.
- People may barbecue using established barbecue pits and using store bought briquettes only. No sticks, branches, paper, cardboard or anything that would allow flame or wind to blow sparks or embers.
- 3. Gas/Propane grills may be allowed but must be away from trees, grass, brush, etc.
- People must abide by any and all fire restrictions imposed that apply during any given fire season in accordance with the Weaverville Fire District, US Forest Service and Cal-Fire guidelines.

### G. Animals

- 1. No Person Shall bring into the boundaries of the park (unless approved through special event)
  - a. Horse, mule, burrow, pony, etc.
  - b. Dog or cat unless said dog or cat is either on a leash and or attended by its owner and owner which has full control of said dog or cat.
  - c. Any other animal not named in this section.

## 4. VIOLATION - Penalty

It shall be unlawful for any 'Person' to violate any provisions of this chapter. Any violation thereof shall constitute and be a misdemeanor and shall be punishable by a fine of five hundred dollars or by confinement in the county jail up to six months, or by both fine and confinement. Each separate violation of this chapter shall constitute a separate offense.

### 5. EFFECT

This ordinance shall take effect thirty (30) days after its passage and shall be published at least once in the Trinity Journal within fifteen (15) days after its passage.
